We will only share information with other organisations where we have your permission to do so in accordance with our Privacy Policy or where it is necessary for a legitimate reason connected with the services we offer, or where it is required by law or regulation.

You have the right to ask for a copy of the information we hold about you (for which we may charge a small fee) and to have any inaccuracies in your information corrected.

The Chinese Community Centre may arrange for photographs or videos to be taken of activities and published on our newsletter, website or social media channels to promote the Centre.
